
DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 96 Jts and cut jt (3063') 8-5/8" OD 32# and 24# Gr J-55 and H-40 SS casing. Set and cemented at 3098' with 1550 sacks 4% Gel and 150 sacks Neat on bottom. Plug at 3074'. Maximum pressure 1250#. Job complete by BJ 10:AM 11-8-54. Circulated estimated 75 sacks cement.

After waiting over 30 hours, tested 8-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 3074' to 3098' and tested below casing shoe with 1000# for 30 minutes. No drop in pressure.
