FULL DETAILS OF PROPOSED PLAN OF WORK

(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pull rods, pump, tubing and packer.
2. Plug back w/sand to 6740' and w/Hydromite to 6715'.
3. Ran GR/N/CCL Survey from TD-3000'.
4. Perforate selected intervals in Zone I based on GR/N log.
5. Set cast iron bridge plug at 6650'. Run 3" frac tubing and full bore retrievable packer. Hydrotest tubing to 8000 psi. Set packer at 6550'.
6. Treat new perforations down tubing below packer w/20,000 gallons lease oil containing 1# 20-40 mesh sand/gallon and 1/20# Mark II Adomite/gallon. Shut in overnight.
7. Pull 3" tubing and retrievable packer.
8. Run 2" production tubing, swab test, place on production.
