(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

PROPOSED OPERATION

1. Pull tubing. Shoot 100 grain/ft. string shot over 7800' - 7960' & 8050' - 8090'. Rerun production tubing without standing valve.
2. Treat for sulfate scale removal as follows:
 - a. Pump 1000 gallons oil w/1% "Blockbuster" chemical.
 - b. Pump 805 gallons 5% acid + FSD Chemical (750 gal. acid & 55 gal. FSD).
 - c. Pump 30 bbls. fresh water containing 55 gallons of SD chemical.
 - d. Shut in 48 hours.
3. Run standing valve & place on production.
