DETAILS OF WORK

It is intended to drill a well at the above location with rotary tools, to an approximate total depth of 6780' in the Drinkard and Tubb formations. Casing will be cemented in accordance with USGS regulations and other special requirements will be complied with.

The following casing program is planned: 8 5/8" OD 24# J-55 set at 1400' with 500 sx cement to return to surface. 5 1/2" OD 14# J-55 to 5400' and 5 1/2" OD 15.5# J-55 from 5400' to 6780'. 5 1/2" casing to be cemented with 500 sx cement and to return to 2500'.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
