It is intended to drill this well with rotary tools at the above location to an estimated TD of 5950'. Casing will be cemented in accordance with U.S.G.S. standards, and other special requirements will be complied with.

The following casing pattern, with approximate amounts of cement, is planned: 10 3/4" OD set at 150' with 250 sacks, cement to circulate; 7 5/8" OD set at 3150' with 1100 sacks, cement to return to 1200'; 5 1/2" OD set at 5950' with 500 sacks, cement to return to 3150'.

Permission is requested to produce this well upon completion.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
