1. Pull rods, pump and tubing.
2. Set CIBP @ 6850' and cap w/cement.
3. Run GR/CCL survey from 6800' to 3100'.
4. Perforate 6572' - 6576', 6582' - 6588', 6606' - 6612', 6646' - 6654' w/2 JSPP.
5. Run tubing open ended w/retrievable packer.
6. Wash perforations w/500 gallons 15% BDA, then treat w/2000 gallons 15% NEA.
7. Swab test.
8. Additional work will be contingent on testing results.
