

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

At 6:45 PM, August 15th, 1938, 72 hours had elapsed, at which time we tested 9-5/8" CD new casing set at 1341 and cemented with 500 sacks.

We conducted the test in the following manner: Built up 1000# pressure, closed valves, and held for 30 minutes. Tested okay, drilled plug, built up 1000# pressure, closed valves and held for 30 minutes.
