FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

On November 21, 1947 at 12:45 AM 24 hours will have elapsed since running 225' of 13-3/8" 48# new casing in subject well and cementing with 150 sacks, to be used as surface string. At this time casing shut off will be tested as follows:

A pressure of 750# will be built up and held for 30 minutes, and if test is OK, cement plug will be drilled and a pressure of 750# again built up and held for 30 minutes. If this test, too, is ok drilling operations will be resumed.
