Spudded 17-1/4-inch hole at 1:00 A.M., 5-20-55.

Ran 8 joints 13-3/8-inch OD 4 1/2" casing, total of 338.06 feet, set at 3531.06 feet. Cemented with 300 sacks 4% gal cement, slurry 15.2%, and 50 sacks regular cement, slurry 15.8%. Plug on bottom at 6:30 P.M., 5-21-55. Maximum pressure 400#.

Tested casing with 700# GWP for 30 minutes. Test O.K. No drop in pressure.
