Dear Mr. Utz:

We request Humble's New Mexico "V" State Well No. 5, Tubb Gas, Unit M, Section 10, T-21-S, R-37-E, Lea County, be reclassified from marginal, as shown in the April 1970 Southeast Gas Proration Schedules, to nonmarginal.

NMOCC Order No. R-3742 authorized Humble to form a standard 160-acre gas proration unit from two nonstandard units comprising the N/2 SW/4, SW/4 SW/4 and SE/4 SW/4, Section 10, to comprise the SW/4 of the Section, T-21-S, R-37-E, Lea County, and dedicate the acreage to Humble's New Mexico "V" State Well Nos. 5 and 11 located in Units M and K, respectively.

New Mexico "V" State Well No. 5 was recompleted as a Tubb Gas Well on May 26, 1969 with AOP of 1,506 MCF/D and was placed on production August 29, 1969.


Gentlemen:

Humble Oil & Refining Company respectfully requests reallocation of acreage dedicated to its New Mexico "V" State Well No. 5, Tubb Gas Well, located in Unit "M", Section 10, T-21-S, R-37-E, Lea County, New Mexico, to include the W/2 and SE/4 of SW/4 of Section 10, a total of 120 acres.

NMOCC Order No. R-3742 authorized Humble to form a standard 160-acre gas proration unit from two nonstandard units comprising the N/2 SW/4, SW/4 SW/4 and SE/4 SW/4 Section 10, to comprise the SW/4 of the Section, T-21-S, R-37-E, Lea County and dedicate the acreage to Humble's Nos. 5 and 11 New Mexico "V" State wells located in Units M and K, respectively.

Reallocation is necessary due to New Mexico "V" State Well No. 11, Unit K, Section 10, T-21-S, R-37-E, being reclassified from a Tubb Gas Well to a Tubb Oil Well effective December 1, 1969.
