The following casing pattern is planned: 10 3/4" OD set at 250' with 250 sacks of neat, cement to be circulated to surface; 7 5/8" OD casing to be set at 3150' with 100 sacks neat. Depth and number of sacks of cement are approximate. Exact amount of cement will be determined by caliper survey approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

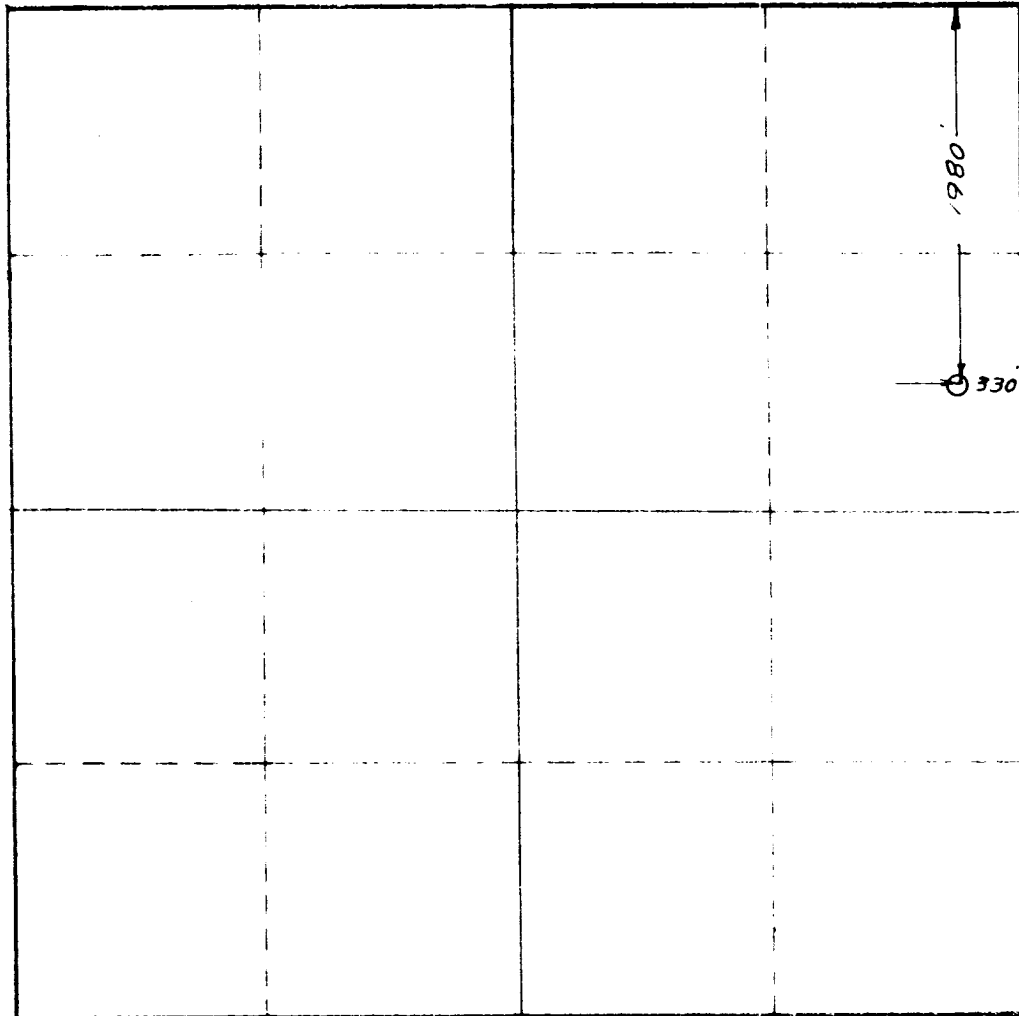
