5-8-90 MIRU. Tagged TOC @ 7455'. PUGH 2'. Load & circ hole w/175 bbls mud. Spot cmt from 7363' to 7453'. Pump 10 sx Class H cmt. Disp w/42 bbls mud. PUGH to 5837'. Load hole w/5 bbls mud. Pump 25 sx Class H cmt. Displ w/32 bbls mud. POOH w/ WS. Perf 5 1/2" csg @ 3200'. Pump 70 bbls mud to load hole. Pump 25 sx Class C cmt & displ w/18 bbls mud. PUGH to 1500'. Load hole w/8 bbls mud. Pump 11 sx Class C cmt across top of salt (1391' - 1500') & displ w/8 bbls mud. POOH w/WS. Perf 5 1/2" csg @ 315'. Pump 10 bbls mud to load hole. Pump 60 sx Class C cmt to fill up 7 5/8" x 5 1/2" annulus & set surf plug in 5 1/2" csg. Pump 55 sx Class C cmt to fill up 10 3/4" csg. Cut off all csg strings & install P&A marker.
