01/10/02 Test anchors. Move in and rig up. Pull out of hole and lay down rods and tubing.

01/11/02 Run in hole and tag bottom @ 6202'. Run in hole w/ 5-1/2" scraper to 6200'.

01/15/02 Run in hole w/ 2-3/8" polylined tubing and packer, set packer @ 5562'. Displace backside w/ packer fluid and test casing to 500#. Wellhead had slight leak in packoff assembly in upper flange. Replace packing elements in wellhead.

01/16/02 Pressure test casing to 500# - OK. Hook well up to injection system and put on injection.

02/05/02 Pressure test casing and chart - OK. (See attached chart)
