

Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were grown in the YEA medium for 24 h at 28 °C. The cell concentration of the *Agrobacterium* strains was adjusted to 10⁸ cells/ml. The cell suspension was then mixed with the plant protoplasts and cocultured for 48 h. The transformation efficiency was determined by the number of GUS-positive cells. The results were expressed as the mean \pm SD of three independent experiments.
