Detailed account of work done, nature and quantity of materials used, and results obtained.

1. Pulled rods, pump & tubing. Ran JB on wireline to 7020'.
2. Set Baker GIBP @ 7000' & capped w/1 1/2 sx. cement.
3. Ran GR/N - CCL & Cement Bond surveys. Bond log indicated top cement @ 5345' w/sufficient bond over Blinebry section.
4. Perforated 5708' - 5745' w/1-1/2" JSPF. Ran frac tubing & packer to 5596'.
5. Treated perforations w/1000 gallons 15% spearhead acid. Treated w/21,000 gallons lease crude containing 1# sand & 1/20# Mark II Adomite/gallon in 3 stages using ball sealers.
6. Pulled frac tubing & ran 187 jts. (5803') 2" tubing & hung @ 5813'. Seating Nipple @ 5777'.
7. Recovered load.
8. On OPT flowed 182 BOPD (based on 53 BO in 7 hours) cut 0.2% wtr., thru 16/64" choke. FTP 320 psi. Gravity 39.6 deg. API.


