6795' w/4 JSPT. Trtd perfs w/6000 gal 15% acid, 4000 gal crude. Ran dual tbg.  
strings. Perf Abo tbg 7011-7014' w/8 holes. Installed pumping unit for Drinkard.  
AFTER WORKOVER: TD 8565', PB 7390', KB 11', Elev 3487 KB, Csg Pt 7" at 8563', Pay  
Drinkard 6735-6797'. Drinkard Perfs 6735-45', 6750-55', 6760-65', 6770-6795'.  
Pmp 65 BO, 70 BW, 22 hrs w/gas at rate of 53.28 MCFPB. GOR 814, DOR 71, Daily Allow  
62 BO. Drinkard portion of workover started 4-15-61, Comp 4-25-61, Tstd 4-26-61.  
Well was recomp in Wantz Abo Pool on 1-26-61 and redesignated Lockhart B-12 No. 3-A.  
Well has now been dual completed in Wantz Abo and Drinkard Pools and is redesignated  
Lockhart B-12 No. 3-AD. This final covers Drinkard comp only. See Final dtd 1-27-61  
for Wantz Abo comp.
