Apache Corporation requests approval of the Temporary Abandoned status following submission of a casing integrity test. Field personnel are checking records from Conoco regarding presence of a CIBP in wellbore. If no CIBP is located, we propose to set CIBP @ +/- 5650' and perform casing integrity test. BLM will be notified 24 hours prior to pressure test.

Apache is actively pursuing development in this area and we plan to use the wellbore in a secondary recovery project to be implemented within the next 12 months.
