The following casing pattern is planned: 8 5/8" OD casing set at 1425' with 700 sacks neat, cement to be eirculated to surface, 5 1/2" OD casing set at TD with 1,000 sacks, cement to return to approximately 1300': Depth and number of sacks of cement will be determined by caliper survey. Approval to produce this well upon completion is also requested.
