DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 193 joints 7180' of 5½" OD 14-15½-17# J-55 SS Casing. Set and cemented at 7193' w/735 sacks 4% Gel slow set cement. Plug at 7117'. Maximum pressure 1800#. Gulf temperature survey in 10 hours found top cement 2970'.

After waiting over 30 hours tested 5½" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement from 7117' to 7175'.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to complete well.
