Total Depth 6634' Line. Moved in tools, pulled tubing. Perforated Blinberry gas zone thru 5 $\frac{1}{2}$ " casing w/4 jet shots per foot from 5527 to 5575, 5587 to 5633, 5650 to 5686, 5712 to 5752. Set packer @ 6483'. Acidized thru perforations w/3000 gallons 15% acid and 500 gallons mud acid. Washed by formation w/250 gallons mud acid. Final casing pressure 1820#, tubing pressure 380#. Completed final report.
