As per State Form C-102, dated 4/8/53, perforated 5 1/2" casing from 5648' to 5718 and treated W/2000 Gallons 15% LSF acid. Well flowed at the rate of 393,000 cu ft p/d on 1/4" Choke. T.P. 150#. Dolefrac thru 5 1/2" casing perforations from 5648' to 5718' W/3000 Gallons - In 8 hour test, well flowed at the rate of 1,097,000 cu ft gas per day thru 3/4" choke. TP 150#. Will continue producing oil thru tbg from the Drinkard section and will produce gas thru casing from the Blinbery section. Dual completion finished 4/11/53 -
