This well is presently a dual comp. in the Amrose Skelly Grayburg & Drinkard Oil pools. Drinkard zone is shut-in due to depletion w/ no workover possibilities. Propose to Abandon Drinkard zone 6476'-6650' by setting a CIBP @ 6425' (Packer set @ 6417') and cap w/ 35' cement. Restore Amrose Skelly Grayburg zone to production.

Recent packer leakage tests indicate packer leaking. THIS well preclude further testing. (SEE NMOC LETTER To Amoco 4-22-76)
