Pan American Petroleum Corporation submits this application for approval of a 160 acre non-standard gas proration unit in the Bumet Gas Pool consisting of the following acreage:

TOWNSHIP 21 SOUTH, RANGE 17 EAST
SW/4 of SECTION 16

This unit will be assigned to our State "U" Tract 12 Well No. 3 located 1980' from the North Line and 660' from the West Line and in the SW/4 SW/4 of Section 16, T-21-S, R-17-E, NEPM, Lea County, New Mexico.

In support of our request for exception to Rule 5(a) without notice and hearing the following is submitted:

1. Application is submitted in triplicate.
2. The proposed non-standard gas proration unit
 - (a) consists of contiguous quarter, quarter sections
 - (b) lies wholly within a single governmental section
 - (c) may reasonably be presumed to be productive of gas
 - (d) length or width does not exceed 3200'
 - (e) lies within the horizontal limits of the Bumet Gas Pool.
3. By copy of this letter of application, all operators owning interest in the section in which the non-standard gas proration unit is situated and which acreage is not included in said non-standard gas proration unit and all operators owning interest within 1900' of the well have been notified by registered mail of this application as shown on the attached mailing list.
