### DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

At 4:00 A.M., on July 21, 1947, 24 hours had elapsed since running 13 3/8" O. D. new 54.5# casing and setting at 322 feet, cementing with 300 sacks cement to be used as surface string. At the time mentioned, casing shut-off was tested as follows:

A pressure of 750# was built up and held for 30 minutes; test was OK. Cement plug was drilled and a pressure of 750# again built up and held for 30 minutes. This test, too, was OK, and drilling operations were resumed.
