DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On Sept 29, at 10:00 pm, 30 hours had elapsed since setting 2900' of 9-5/8" OD 36# casing in subject well and cemented with 1500 sacks cement. At this time casing shut-off was tested as follows:
 A pressure of 1000# was built up and held for thirty minutes, and as casing tests were o.k., cement plug was drilled and a pressure of 1000# again was built up and held for 30 minutes. As this test was o.k., drilling operations were resumed.
