Ran and cemented 212 1/2 jts. 6631' of 5 1/2" casing at 6650' with 350 sacks. Completed at 4:40 A.M. 11-9-52.

Commenced drilling cement plug at 10:00 P.M. 11-10-52. Tested casing by pressure method before and after drilling. Tested okay.

5 1/2" casing was perforated from 6604' to 6645' with 4 jet shots per foot. Perforations were washed with 500 gallons of mud acid.
