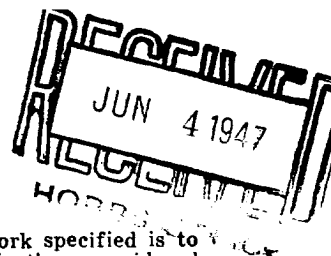

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

We propose to carry 7-7/8" hole to approximately 6,644', run Schlumberger survey, and run 5-1/2" OD 15.5# casing to 6,641'. Drill out cement to approximately 6,637' and perforate opposite the most likely pay section.

We expect to start this work on June 3rd, 1947.
