September 24, 1966 pump oil down both zones to kill well. Pulled short and long string tubing leaving tail pipe sealed in Baker Model "B" packer. Found various pitted joints in long string. Ran 201 joints of new 2 1/16" OD 1.750 I.D. 1.1. tubing (6334') and latched back into Model "B" pressure tested tubing 8000 for 30 minutes. Ran dual string of 2 1/16" OD 1.750 I.D. 1.1 tubing with perforations at 5463'. Swabbed in both zones. Work completed October 14, 1966. Ran packer leakage test October 18-22, 1966. Test indicated no leakage.

Instructions
