## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

2880' Total Depth, Lime. Ran temperature survey and found top of cement at 475', 36.2% of calculated fill. Nippled up 8-5/8" Casing, went in hole with 7-3/8" bit and drilled out cement from 2785' to 2880'. Tested casing with 1000# for 30 minutes before and after drilling cement and was OK. Started drilling 7-3/8" hole at 8:00AM, 12-19-47.
