Well is presently NIO in the Penrose Skelly Pool. It is proposed to deepen from present TD at 3800' to 5500' and attempt a Paddock completion as follows:

Drill from 3800' to 5500' with 4-3/4" bit. Run logs. Run 4" liner with B & W liner equipment to rotate when cementing. Cement with 300 sacks Class "C".

Paddock perforations to be picked from logs. Treat Paddock perforations down 2-3/8" tubing using ball sealers. Acid volume to be dependent on feet of porosity from log.
