Gentlemen:

Application is made herewith for a 40-acre non-standard proration unit in the Tubb Gas Pool for J. R. Cone Anderson Well No. 1. The non-standard unit will comprise all of the J. R. Cone Anderson lease, being all of the Northeast Quarter of the Southeast Quarter (Unit I) of Section 21, T-21-N, R-37-E, NMEP, Lea County, New Mexico. The location of Anderson Well No. 1 and the acreage to be dedicated thereto are shown on the attached Form C-128 "Well Location and Acreage Dedication Plat".

For your information, J. R. Cone Anderson Well No. 1 is a dual completion in the Drinkard Oil and Tubb Gas Pools. Dual completion of the well was effected in November, 1951 under New Mexico Oil Conservation Commission Order No. 2-83.

Each offset operator in the Tubb Gas Pool to the J. R. Cone Anderson lease is being supplied a copy by certified mail of this Application, including a copy of the "Well Location and Acreage Dedication Plat". Waivers are not being requested of the offset operators as it is planned to abide by the waiting period prescribed in the Commission regulations for the administrative handling of non-standard proration unit applications.

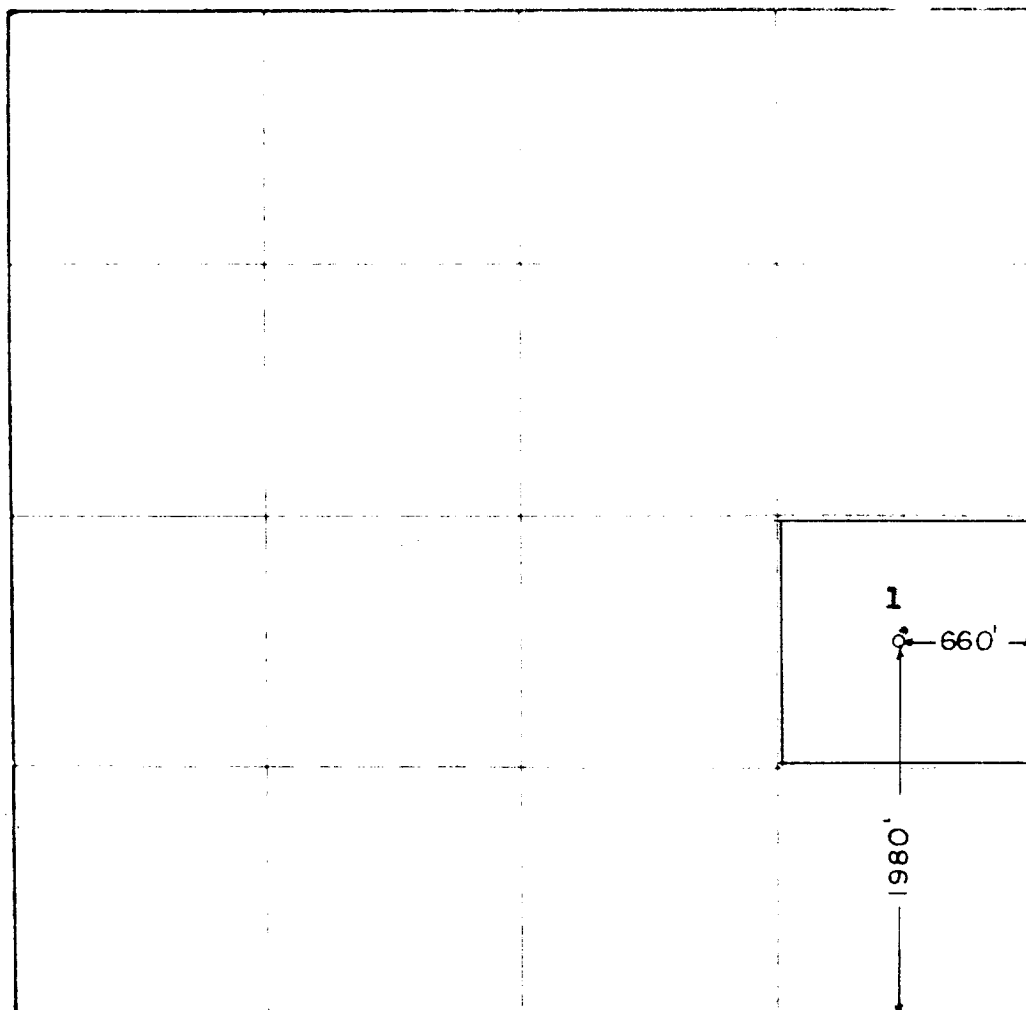
