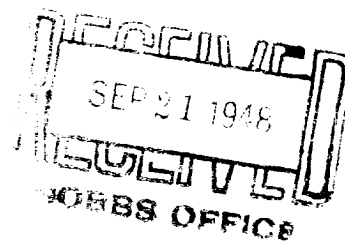

Smith, R-3, csg w/short T&C on bottom & 230 jts, J-55, R-2, csg w/long T&C on top) w/one 7" Weatherford Casing Centralizer @ 6496'. Total tallies 6489', H-11, set @ 6500'. Cemented by Halliburton w/575 sacks 2% & 125 sacks neat bulk cement. Plug @ 6451'. Job started @ 11:30 p.m. on 16th and completed @ 10:45 a.m. on 17th.

Propose to drill plug and test shut-off @ 10:45 a.m., September 19, 1948.
