On November 29, 1948, ran 188 jts of new 7" OD, 23#, 8 Rd Thd, A. O. Smith, H-Y and J-55, R-2 and 3 SS csg (20 jts A. O. Smith R-3 on bottom and 168 jts of J-55, R-2 and 3 on top w/five 7" Weatherford csg centralizers spaced @ 6546', 6497', 6405', 6313', and 6200' and twenty-five 7" Weatherford scratchers spaced from 6232' to 6550'. Casing tallies 6539', H-11', set @ 6550'. Cemented by Halliburton w/575 sacks 2% and 125 sacks of neat bulk cement. Plug @ 6501'. Job started 3 a.m. and completed 3:50 p.m.

Propose to drill plug and test shut-off @ 3:50 p.m., December 1, 1948.
