One Weatherford centralizer placed @ 6546'. Total tallies 6539', H-11', set @ 6550'. Cemented by Howco with 575 sacks of 2% Aquagel and 125 sacks of Reg. Portland Lone Star bulk cement. Plug @ 6500'. Job started @ 11:45 a.m. and completed @ 7:35 p.m.

Propose to drill plug and test shut-off @ 7:35 p.m., February 8, 1949.
