DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 213 joints 7506.09' of 5½" OD 15½ & 17 & 14# J-55 & N-80 SS Casing. Set and cemented at 7519' w/290 sacks 4% Gel Trinity inferno cement. Plug at 7431'. Maximum pressure 900#. Gulf temperature survey in 12 hours found top cement behind 5½" casing at 5845' from rotary bushing.

After waiting over 30 hours tested 5½" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement plug from 7431' to 7514'

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
