DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 10 joints 299' of 13-3/8" OD 48# H-40 SS casing. Set and cemented at 315' w/360 sacks Lone Star regular cement. Plug at 290'. Pressure 400#. Circulated 20 sacks cement.

Tested 13-3/8" casing w/600# pressure for 30 minutes. There was no drop in pressure. Drilled cement plug from 290' to 315', tested cement below shoe w/400# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
