## FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

PROPOSED OPERATION: Abandon Drinkard and Recomplete to Blinebry Oil.

1. Pull tubing and packer.
2. Set CIBP at 6400' and cap w/cement.
3. Perforate Blinebry with 1-3/8" jet shots as follows: 5674', 5678', 5685', 5692', 5708', 5711', 5726', 5743', 5755', 5773', 5781', 5787', 5797', 5803', 5807', 5814', 5857', 5861'.
4. Run 3" tubing and full bore retrievable packer.
5. Treat w/1800 gallons 15% NE acid.
6. Treat via 3" tubing w/20,000 gallons lease oil containing 1# sand and 1/20# Mark II Adomite per gallon in 2-10,000 gallon stages using ball sealers between the stages.
7. Pull 3" tubing and packer. Run 2" production tubing.
8. Swab test and place on production.
