TD 7055' - PBD 6400'
7 5/8" csg. at 3180' w/1253 sx. 5 1/2" liner from 2915' to 7055' w/425 sx. 6% gel.
Blinebry Perfs. 5715-5927' Tubbs Perfs. 6205-6254' Abo Perfs. 7000-7050'.
Propose to kill well w/oil, install BOP & pull all 2" tubing. Run 2" tubing & set in Baker Model "D" at 6185' and squeeze Tubb perfs. 6205-6254' w/75 sx. Trinity Inferno. Drill out Model "D" & cement to 6300' and pressure test Tubb Perfs. 6205-6254' w/ 1500 psi for 30 minutes. Drill out cement & Baker CI BP from 6300-6400' and clean out to 7050'. Run cement retainer on 2" tubing to 6900' and squeeze Abo perfs. 7000-7050' w/50 sx. Trinity Inferno. Perfs. Drinkard pay from 6464 to 6594' w/1 Jet shot per foot. Reference McCullough GR-N dated 9-22-53. Run treating packer on 3 1/2" tubing and set at 6400'. Acidize Drinkard perfs. w/500 gals. 15% NE acid. Sand-oil frac. w/30,000 gals. Refined oil + 90,000# of 20-40 sand. Dual complete Blinebry and Drinkard with combination 2 3/8" & 2 1/16" tubing.
