Your letter of July 5, 1962 requesting the revision of Administrative Order DC-16-A was received by this office July 9, 1962. It is requested that you file for the requested change in the completion of your D. A. Williamson Well No. 1 from a gas-gas dual to an oil-gas dual in the manner as for an original application, using the usual dual completion application forms and including all information required by the application.

The above request is made due to the fact that DC-16-A permitted the production of gas from the Blinbry formation through the casing-tubing annulus where as the production of oil is not permitted by such means.
