DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 217 jts 7136' of 5 1/2" OD 17, 15.50 and 14# J-55 SS Casing. Set and cemented at 7149' w/ 550 sacks Trinity inferno 4% Gel bulk cement. Plug at 7077'. Maximum pressure 1200#. Gulf temperature survey after 10 hrs showed top of cement at 3982' below rotary table.

After waiting over 30 hours tested 5 1/2" casing w/ 1000# pressure for 30 minutes. There was no drop in pressure. Drilled plug and cement from 7077' to 7146' and cleaned out to bottom.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to complete well.
