DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 10 joints 208' of 12-3/4" OD 45# SS Casing. Set and cemented at 222.83' w/275 sacks Regular Neat cement. Plug at 210'. Maximum pressure 200#. Cement circulated.

After waiting over 24 hours tested 12-3/4" casing w/500# pressure for 30 min. There was no drop in pressure. Drilled cement plug from 210' to 222', tested cement below casing shoe w/400# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
