FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to fracture treat as follows:

1. Pull rods, pump and tubing.
2. Run 2-7/8" tubing with retrievable bridge plug and full bore packer, straddle bottom perforations from 5820-5854'. Treat perforations with 12,000 gallons refined oil with 1# sand per gallon. Straddle upper perforations from 5756-5788' and treat with 12,000 gallons refined oil with 1# sand per gallon. Pull tubing, bridge plug and packer.
3. Run 2-3/8" tubing and return well to production.
