### DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The above well was plugged and abandoned in accordance with Form C-102 Approved August 18, 1952, as follows:

Shot off and pulled 524' of 7 5/8" casing. Cement plugs were spotted at the following depths and the intervals filled with a heavy laden mud: 25 sacks cement plug in bottom of 7 5/8" casing (T.D. - 4496). 25 sack cement plug in 7 5/8" stub and a 25 sack cement plug to surface. A 4" abandonment pipe marker was erected and the location restored to its original contour.
