## FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

The interval from 4336 to 4500' having proved to be non-productive, we propose to plug and abandon the subject well. After loading the hole with mud, the 7-5/8" oil string will be shot and pulled so as to recover as much pipe as possible. The following cement plugs will be set: 10 sacks from 4316' to 4340'; 10 sacks on top of casing stub (estimated 3750' to 3730'); 15 sacks from 2550' to 2570'; 15 sacks from 1550' to 1570'; 10 sacks for 20 feet surface plug.

A 4" x 10' well marker will be erected on completion of the work and the location levelled to conform with the surrounding terrain.
