FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

Intention to drill above well was approved by you September 11, 1936 and well has now been drilled to total depth of 4711' and is a dry hole at that depth. It is our intention to plug this well by running cement plug in bottom of hole extending above any water-bearing formations. Hole is to be filled with mud from that point to bottom of 8 5/8" pipe at 1630'. Hole to be filled with mud within 20' of surface after setting cement plug at bottom of 8 5/8" pipe. Cement plug to be set in top of hole with usual marker in place, i.e. 1 joint of 4" pipe extending 4' above ground level. All rules and regulations of the New Mexico Oil Conservation Commission pertaining to plugging and abandoning of wells will be complied with.
