Shot 8-5/8 casing loose at 2200 and spotted a 20 sx cement plug at this point after running back tubing. Shot 10-3/4 loose at 800, ran tubing back and spotted a 20 sx plug at 800. Ran a 15 sx cement plug in the top. Placed a 4" marker 5' above ground.
