PROPOSED OPERATION

1. Kill well, pull tubing, & run Caliper Survey.
2. Run 3" X-line frac tubing w/Lynes packer. Set packer no higher than 3850'. Hydrotest tubing to 6000 psi.
3. Treat open hole 3806' - 3946' down tubing w/20,000 gallons lease crude containing 1# 20-40 sand/gallon and FLA.
4. Pull 3" tubing and rerun 2" production tubing w/Lynes production packer.
5. Swab load and place on production.
