2. Shoot one 300 grains/foot string shot over the open hole 3775' - 3860'; then shoot one 500 grains/foot string shot over the same interval.
3. Treat w/500 gallons 15% NE acid.
4. Run tubing and swab test.
5. Run pump and rods.
6. Place on production.
