FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

It is proposed to transfer 50% or the maximum amount of allowable permitted under New Mexico Oil Conservation Commission Orders, from Shell Coleman No. 1 to Shell Coleman No. 2 in order to conserve gas and reservoir energy. Coleman No. 2 has a potential of some 500 barrels per day and a gas-oil ratio of 987 cubic feet per barrel of oil. Coleman No. 1 has a gas-oil ratio of 42,600 cubic feet per barrel of oil. A plat of the Coleman Lease and the offset wells is attached.
