DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This well was plugged back from 3941' to 3934' with gravel then to 3924' with Lead Seal, above which gravel was placed to 3920'. Hole was loaded with 180 quarts 380 to 3870' and a gravel tamp placed to 3876'. It was then cleaned out to 3924' and 2" tubing run to 3901' with an American Flow Packer set at 3779'. As a result of this work the well is producing at the rate of 4 barrels per hours.
